Organizers of charity events will be allowed to briefly speak about their events. If any clubs have topics that they would like to discuss at the meeting, please let us know in advance of the meeting so we can allow time for their discussion. The cut-off date for event submissions will be February 28th 2011. Please get us any last minute changes by this date so we can distribute the calendar as early as possible in March 2011.
